Close Reading of Key Texts Featuring Neurodivergent Protagonists

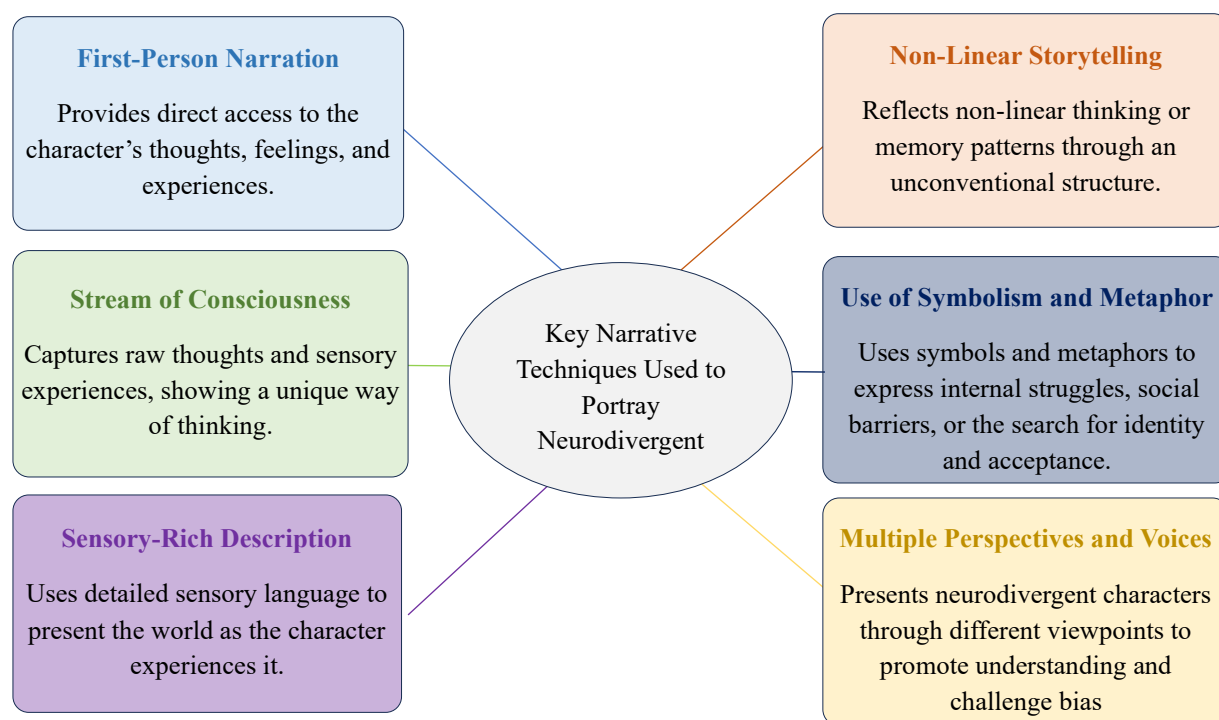


Figure 1: Key Narrative Techniques Used to Portray Neurodivergent Characters

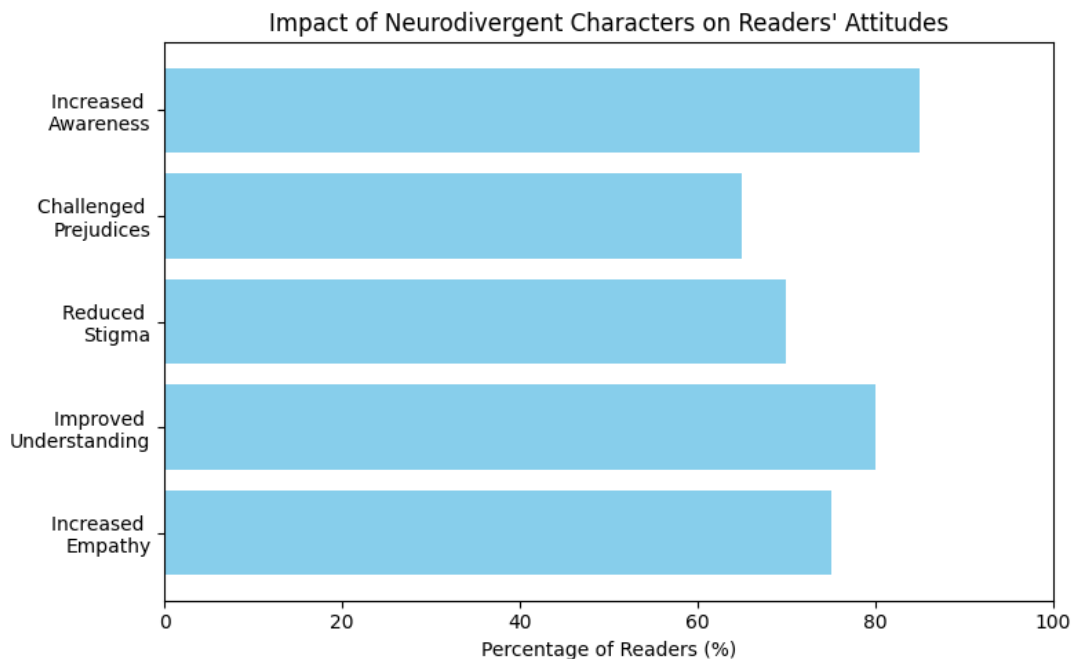


Figure 2: Impact of Neurodivergent Characters on Readers' Attitudes
